**The following items are PROHIBITED for sale at the Georgia Blueberry Festival:**

1. All alcoholic beverages;
2. Functional firearms or toy firearms. An exception to this prohibition would be handmade wooden toys designed not to fire a hard projectile;
3. Knives to anyone under the age of 18. If you have knives for sale, they need to be in a closed case in a location where they can be seen by adults, but not reached by children;
4. Any explosive devices including, but not limited to, fireworks, sparklers, stink bombs, or smoke bombs;
5. Toy or replica tobacco products.

No refunds will be issued to vendors within fourteen days prior to the festival date. No refunds will be made for weather.
