Completion of this application does not guarantee your acceptance into the Georgia Blueberry Festival. The committee will assign vendor locations. Priority will be determined based on the date your application is received.

#### The following items are PROHIBITED for sale at the Georgia Blueberry Festival:

- 1. All alcoholic beverages;
- 2. Functional firearms or toy firearms (guns, rifles, BB guns, etc.). An exception to this prohibition would be handmade wooden toys designed not to fire a projectile;
- 3. Knives to anyone under the age of 18. If you have knives for sale, they need to be in a closed case in a location where they can be seen by adults, but not reached by children;
- 4. Any explosive devices including, but not limited to, fireworks, sparklers, stink bombs, or smoke bombs:
- 5. Toy or replica tobacco products.
- 6. Vapors and their products.
